MEDICAL EXEMPTION POLICY:

All students are advised that the SUNY COVID-19 vaccine policy requires completion of a full vaccine series. Completion of a full COVID-19 vaccine series is defined as having received the both doses in a two-dose series (e.g., Pfizer-BioNTech or Moderna) plus a booster once eligible or having received a single-dose vaccine (Johnson & Johnson/Janssen) plus a booster once eligible. Students may be exempt from the mandatory vaccination requirement if a licensed healthcare provider certifies in writing that the student has a medical contraindication to the COVID-19 vaccine. Students requesting medical exemption are required to submit the completed documentation from a healthcare provider.

Upon review, the student will be notified by campus email of the outcome of the request. This form and any supporting documents should be emailed to the Director of Student Health and Counseling Services at <u>babowidp@morrisville.edu</u>.

I am aware that

should a COVID-19 outbreak occur at the campus that I may be excluded from all in-person classes and activities and that if I am enrolled in courses that require a physical presence on campus that I may not be able to complete my academic coursework remotely. I acknowledge that any refund I might be entitled to in the case of a COVID-19 outbreak would be subject to all existing SUNY policies.

Part II. Medical Exemption Request (to be completed by medical provider)

Local injection site reactions to previous COVID-19 vaccines (erythema, induration, pruritus, pain).

- Expected systemic vaccine side effects in previous COVID-19 vaccines (fever, chills, fatigue, headache, lymphedema, diarrhea, myalgia, arthralgia.
- Previous COVID-19 infection.
- Vasovagal reaction after receiving a dose of any vaccination.
- Being an immunocompromised individual or receiving immunosuppressive medications.
- Autoimmune conditions, including Guillain-Barre Syndrome.
- Allergic reactions to anything not contained in the COVID-19 vaccine, including injectable therapies, food, pets, oral medications, latex etc. (Please note the COVID vaccine does not contain egg or gelatin).
- Alpha-gal Syndrome.
- Pregnancy, undergoing fertility treatment, intention to become pregnant or breast-feeding. (Please note the American College of Obstetricians and Gynecologists, the Society for Maternal-Fetal Medicine and the Society for Reproductive Medicine all strongly recommend COVID-19 vaccination during pregnancy).
- The medical condition of a family member or other residing in the same household as the employee.

Clinician Certification: By completing this form, you certify that different methods of vaccinating against COVID-19 have been fully considered and that the patient has the contraindication indicated above that precludes any/all available vaccinations for COVID-19. Section B. Medical Provider Certification of Disability That Makes COVID-19 Vaccination Inadvisable

"Disability" is defined as any impairment resulting from anatomical, physiological, genetic, or neurological conditions which prevents the exercise of a normal bodily function or is demonstrable by medically accepted clinical or laboratory diagnostic techniques and any other condition recognized as a disability under applicable law.

"Disability" may include pregnancy, childbirth, or a related medical condition where reasonable accommodation is medically advisable.
