# MANDATORY REQUIREMENTS

Prior to arrival to campus, all students registered for 6 credit hours or more <u>MUST</u> submit the following:

- 1. Verification of MMR immunity
- 2. Meningococcal Meningitis Vaccine Date(s) or Refusal Letter
- 3. Physical Exam and Health History
- 4. Tuberculosis Questionnaire and Testing (if applicable)
- 5. Parental consent for care of minors (if applicable)

# **COVID-19 REQUIREMENTS**

All students are strongly encouraged to stay up to date on their initial course of vaccinations and booster. As of 4/11/2023, COVID-19 vaccination is not required for attendance at a SUNY school unless required by the academic program.

Non-compliance with the mandatory requirements will result in dismissal from SUNY Morrisville.

#### **NEW YORK STATE LAW: MMR REQUIREMENTS**

Records may be located at your previous college, high school, or family doctor's office.

In accordance with NYS Law any student born after January 1, 1957, must provide proof of immunity to measles, mumps, and rubella, this requirement may be met by the following: proof of disease, immune titers, or two {2} measles, one {1} mumps, and one {1} rubella vaccine given after the student's first birthday).

## **NEW YORK STATE LAW: MENINGOCOCCAL MENINGITIS VACCINE**

The Center for Disease Control Advisory committee on Immunization Practices (ACIP) recently issued a new recommendation for college students registered for 6 credit hours or more: Students, especially those living in residence halls, should consider vaccination to reduce their risk for MENINGOCOCCAL DISEASE.

New York State Public Health Law 2167 requires:

- A response to receipt of meningococcal disease and vaccine information signed by the student or student's parent or guardian (if under the age of 18)
  - AND EITHER
- A record of at least 1 dose of Meningococcal ACWY vaccine within the past 5 years or a complete 2dose series of Meningococcal B
- An acknowledgement of meningococcal disease risks and refusal of meningococcal vaccination response form signed by the student or student's parent or guardian (if under the age of 18).

#### PRE-ADMISSION PHYSICAL

All students <u>MUST</u> submit proof of having had a physical examination within the last 1-2 years prior to the start of their first semester in order to use Student Health Services. This physical exam should preferably be done by your PCP (Primary Care Physician). A one- time courtesy visit will be granted to students not submitting a pre-admission physical.

\*Please note that the Student Health Center does NOT perform pre-admission physicals. \*

#### **TUBERCULOSIS QUENSTIONNAIRE AND TESTING**

All students should complete the Tuberculosis Screening Questionnaire. Tuberculosis skin testing is **REQUIRED** for all <u>High-Risk Students</u>. Students at low risk are not required to undergo tuberculosis skin testing.

#### **HEALTH INSURANCE**

All students taking 12 credit hours, or more are required by federal law to be covered by health insurance. PLEASE CONTACT YOUR HEALTH INSURANCE CARRIER TO BE SURE YOU ARE COVERED FOR MEDICAL SERVICES IN THE SUNY MORRISVILLE REGION. Please be sure to bring your insurance card with you to campus.

#### PARENTAL CONSENT FOR CARE OF MINORS

If a student is under the age of 18 when starting school, a parental consent to treat must be completed and **SIGNED** in order for the Student Health Center to provide care.
